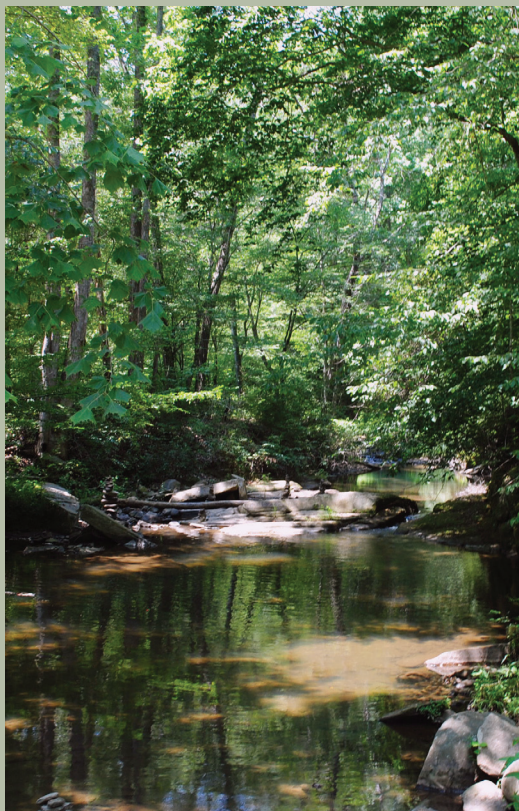

## Camp Mikell Endowment Fund

Legacy gifts in any form, unless otherwise directed by the donor, will be directed to the Camp Mikell Endowment Fund. The Mikell Endowment Fund is administered by the Long Term Investment Committee of the Episcopal Diocese of Atlanta.

## Bequests

One of the easiest ways to make a planned gift is to designate Camp Mikell as a beneficiary in your will. A bequest may be a specific dollar amount, a certain asset, or a percentage of your estate. Your attorney can add a bequest to your will with language as simple as this:

"I give \_\_\_\_\_ Dollars (\$\_\_\_\_\_) [or \_\_\_% of the residual assets of my estate] to the Camp Mikell Endowment Fund of the Episcopal Diocese of Atlanta."

## IRAs or other tax deferred retirement funds

Naming Camp Mikell as a beneficiary of your Individual Retirement Account, 401(K), or other tax deferred retirement funds may provide significant tax advantages. Your employer's human resources office or the broker or other plan custodian of your IRA can provide you assistance in making this type of provision.

## Life Insurance

Another way to make a significant contribution is to name Camp Mikell as beneficiary of an existing or new life insurance policy. Also, making Camp Mikell owner of a permanent policy can provide opportunity for important tax advantages. Your life insurance professional can assist you with making an arrangement appropriate to your circumstances.

## Life Income Gifts

You can take advantage of a gift vehicle known as a charitable remainder trust to provide income for yourself and your spouse for life, and still make a significant gift to Camp Mikell. These trusts, particularly when they are funded with appreciated property, usually provide donors increased income as well as favorable tax benefits. For gifts in smaller amounts, a charitable gift annuity or a pooled income gift provides similar features and benefits. These gift vehicles are available through the Episcopal Church Foundation.
